
Below is a copy of the guidelines provided by Spaulding's Providers for treatment of your child's first aid, minor ailments and preventative health care needs. Medication	Used for:
Acetaminophen- up to every 4-6hr (dose weight based)	Pain, temperature >100 degrees
Ibuprofen- up to every 4-6hr (dose weight based)	
Diphenhydramine 25-50 mg- up to every 4-6 hours	Allergic reaction/hives, dystonia
Nasal saline spray- up to 2-3 times per day	Nasal congestion, dryness
Triple antibiotic ointment	Infection/to prevent infection, burns
Cough Drops	Sore throat/cough
Sunblock SPF 30	Sunburns/prevention
Hydrocortisone cream 1%- up to 2x/day	Itching, bug bites
Caladryl gel- 2-3x/day	Bee sting, poison ivy, allergic reactions
Normal saline or Hydrogen Peroxide 3%	Cuts/ abrasions
Tolnaftate 1% fungal cream- up to 2x/day	Athlete's foot, other fungal infections
Lice Shampoo, use as directed	Treatment of lice
Fiber Gummy, 1 gummy- up to 3 times a day	Constipation
Tums 500 mg- 1 hour after meals up to 4x /day	Heartburn/ upset stomach
Epinephrine 0.15-0.3mg for anaphylaxis. Repeat injection in 5 minutes if first dose not effective. (dose weight based)	For anaphylaxis resulting from bee sting or another allergen
EMLA cream	Numbing cream for injections or blood withdrawal
Phenylephrine 5-10mg every 4 hours (only students >80 lbs)	Nasal congestion (if no seizure history)
Guaifenesin Cough, 1-2 tsp every 4 hours (only students >80lbs)	Cough/expectorant
Carbamoxide ear drops 2-4 drops in affected ear 3x/day for 7 days	Excess ear wax


GENERAL:

- **Lab Protocol:** Labs to be drawn as needed. Monitoring of medication blood levels will be done as requested by prescribing provider, and follow-up for any abnormal values will be drawn as needed.
- **Immunization protocol:** Immunization recommendations will be according to the CDC guidelines and New Hampshire School Immunization Guidelines with additional parent/guardian consent
- **Dystonia Protocol** (for students on anti-psychotic medication): Any students that receive an anti-psychotic medication are at risk for EPS (Extra Pyramidal Symptoms). To assess for any adverse reactions, a licensed member from Health Services will do an AIMS/DISCUS assessment at regular intervals.
- **Ophthalmology Protocol:** Any student that receives the anti-psychotic, Seroquel, is to receive a slit-exam evaluation on a yearly basis.
- **Vision Screening Protocol:** Will be completed annually for all students by the Health Services department.
- **Audiology Protocol:** Will be completed annually for all students or as requested by members of their team.

***For any abnormal findings, student will be referred to a specialist for further assessment.**
